Said obligation to indemnify, defend, and hold harmless, shall also include any claims or lawsuits in which active or passive negligence of Stafford Township or Greitz Communications & Events is alleged and/or proven.

The Vendor agrees to maintain in full force a policy of comprehensive general liability insurance under which Stafford Township and Greitz Communications & Events are named as additional insured, and under which the insurer agrees to indemnify and hold Stafford Township and Greitz Communications & Events harmless from and against all costs, expense, including reasonable attorney's fees, and/or liability arising out of or based upon any and all claims, accidents, injuries and damages arising out of the Vendor's negligent or improper acts in the operation at the event(s) listed below.

The Vendor agrees to name Stafford Township and Greitz Communications & Events as additional insured, and to provide a valid certificate of insurance with a liability limit of at least \$1,000,000 per occurrence.
